Race 4 MERV JENNINGS SIGNS (275+RANK) 3:57 pm 460m Maiden	<p>An out of competition sample was taken from Angelani on 06/02/2024, pursuant to GAR 139.</p> <p>Cabao Nickel was quick to begin. Chasing Chappy was slow to begin.</p> <p>Angelani (stumbled on the home turn) underwent a post-race veterinary examination and was found to have a right gracilis and right long head triceps muscle injuries. A 21 day stand down period was imposed.</p> <p>Chasing Chappy underwent a post-race veterinary examination at the Trainer's request and was found to have a left toe and monkey muscle injury. A 28 day stand down period was imposed.</p> <p>Angelani, Velox Bale and Whipping Along raced wide in the home straight.</p> <p>A post-race sample was taken from Cabao Nickel - the winner of the event.</p>

All greyhounds were removed from the boxes and underwent a veterinary examination. All greyhounds were passed fit to compete and were reboxed after the starting boxes were tested to the satisfaction of the Stewards.</p> <p>Mepunga Riley and Rev Querida were quick to begin. Step On Air, Windy Biscuit and Tea Yemen were slow to begin.</p> <p>Circle The Globe raced wide in the home straight.</p> <p>Tea Yemen (fell approaching the home turn), underwent a post-race veterinary examination - no apparent injury reported.</p>

Firing Chief was slow to begin.</p> <p>Firing Chief and Mad Blast (collided on the first turn causing Firing Chief to fall and Mad Blast to be severely checked and tail off), underwent a post-race veterinary examination. It was reported that Firing Chief was found to have no apparent injury. Mad Blast was reported to have a right gracilis injury. A 21 stand down period was imposed.</p> <p>Following the running of this event, Stewards inspected the track on the first turn and deemed it satisfactory for racing.</p>
