<b>Race 1</b> SPORTSBET WE LET THE DOGS OUT 6:43 pm 390m Tier 3 - Maiden	<p>Eco Bale – New declared weight of 32.2kg, last raced at 30.6kg.</p> <p>Jilliby Mish was quick to begin. County Tyrone was slow to begin.</p> <p>Mars Bale and Muck Around raced wide entering the home straight. Classy Mustang raced wide in the home straight.</p> <p>Runaway Deal (faltered after the finish), underwent a post-race veterinary examination - no injury apparent.</p> <p>Mars Bale (turned its head inwards and visibly eased in the home straight), underwent a post-race veterinary examination and was found to have a left back muscle injury. A 10 day stand down period was imposed. Stewards spoke to Mr Luke Harris regarding racing manners of Mars Bale in the home straight. Acting under the provisions of GAR 125, Mars Bale was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Harris pleaded guilty to the charge and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post-race sample was taken from Eco Bale – the winner of the event.</p>
<b>Race 2</b> SWEET NETTY'S CATERING 7:05 pm 450m Tier 3 - Maiden	<p>A pre-race sample was taken from Ready To Stagger.</p> <p>Paldron Bale and Kalinya were quick to begin. Barellen Moon was slow to begin.</p>
<b>Race 3</b> TOWN & COUNTRY LINE MARKING 7:27 pm 450m Tier 3 - Maiden	<p>Kenneth Bale was quick to begin.</p> <p>A post-race sample was taken from Wisdom Bale – the winner of the event.</p>
<b>Race 4</b> TUDOR ELECTRICAL 7:49 pm 390m Tier 3 - Grade 7	<p>A pre-race sample was unable to be obtained from Fascinate Lacey, a post-race sample was subsequently taken.</p> <p>Pelican Flyer and No Right Turns were quick to begin. Fascinate Lacey was slow to begin.</p> <p>Yamgata Bale (faltered in the back straight and tailed off), underwent a post-race veterinary examination and was revetted after Race 7. It was reported that the greyhound was found to have split webbing to the left and right hindlegs. A 10 day stand down period was imposed. Stewards spoke to representative Mr. J Bryce regarding the performance of Yamgata Bale in this event. Although Stewards noted the injuries sustained to the greyhound, acting in accordance with GAR 122, they requested Trainer Mr C Grenfell to report as soon as practicable anything further that may have affected the running of Yamgata Bale in the event, which was not noted by Stewards during or immediately after the event.</p>
<b>Race 5</b> A1 SIGNAGE (2-3 WINS) 8:07 pm 390m Tier 3 - Restricted Win	<p>Elite Patty was quick to begin. Lala Speed was slow to begin.</p> <p>Rooster Legs (catching pen), underwent a post-race veterinary examination and was found to have a spike wound to the left foreleg and abrasions to the left hind toes. A 7 day stand down period was imposed.</p> <p>A post-race sample was taken from Aviswood – the winner of the event.</p>

<b>Race 6</b> EUREKA CONCRETE 8:29 pm 390m Grade 5 T3	<p>Blackpool Diva and Rose Of Saturn were quick to begin. Quill Bale and Rogan Bale were slow to begin.</p> <p>Blackpool Diva (raced awkwardly and brushed the rail turning on the turn off the back straight), underwent a post-race veterinary examination. It was reported that the greyhound was found to have a left back muscle injury, abrasions to the left hock and spike wounds to the left stopper bone and right hind toes. A 10 day stand down period was imposed.</p> <p>A post-race sample was taken from Rose Of Saturn – the winner of the event.</p>
<b>Race 7</b> SOUTHERN SHEETMETAL 8:51 pm 450m Grade 5 T3	<p>Pursuant to GAR 75(6), starter Ms. Donna Robertson did not act in any official capacity that may have in any way affected the outcome of this event.</p> <p>Little Poppet and Diva Davina were quick to begin.</p> <p>Little Poppet crossed out and raced wide in the home straight.</p>
<b>Race 8</b> PAUA OF BUDDY AT STUD 9:13 pm 450m Grade 5 T3	<p>Pursuant to GAR 75(6), starter Ms. Donna Robertson did not act in any official capacity that may have in any way affected the outcome of this event.</p> <p>Broombrae Fritz, Aston Allure, Good Manner and Pi Grange were quick to begin. Ragin' Ablett and Single Flicker were slow to begin.</p>
<b>Race 9</b> GREYHOUND ADOPTION PROGRAM 9:31 pm 390m Tier 3 - Maiden	<p>Soho Quickly By was quick to begin.</p> <p>Moraine Sally (racing manners approaching the first turn), underwent a post-race veterinary examination – no injury apparent. Stewards spoke to Mr D Elliot regarding the racing manners of Moraine Sally on the turn off the back straight. After hearing submissions from Mr Elliot, viewing the available race footage, in particular the head-on vision, and having their own observations, the Stewards issued a warning to connections.</p>
<b>Race 10</b> SJC CONCRETING (1-2 WINS) 9:55 pm 450m Tier 3 - Restricted Win	<p>Frankly Fever and Kayden's Cuddles were quick to begin. Average Joe went up with the lids at box rise and was very slow to begin (5L).</p>
<b>Race 11</b> DOWNLOAD THE WATCHDOG APP 10:12 pm 390m Grade 5 T3	<p>Ms. Olivia Cartechini was fined \$50 for failing to ensure the registration card was produced for Inter Star Fire, pursuant to GAR 88.</p> <p>Pursuant to GAR 75(6), Starter - Ms. Donna Robertson did not act in any official capacity that may have in any way affected the outcome of this event.</p> <p>Inter Star Fire was quick to begin.
