After taking evidence from Handler, Joe Briffa (representing Trainer - Graeme Bate), acting on their own observations and viewing the official video film, the Stewards found Bukem Bale guilty as charged. Acting in accordance with AGRR 81.1, the Stewards will stand Bukem Bale down from competing for 28 days at Sandown Park only and will require the greyhound to perform a Satisfactory Trial (all tracks) before any future nomination will again be accepted. A swab sample was taken from Paris Bound, the winner of the Event.
