Acting on a recommendation from Dr. Smith, the Stewards will stand Little Things down from competing for 7 days. Stewards spoke to Handler, Mr. G. Robinson (representing - Trainer, L. Bannon), regarding the performance of Little Things. Mr. Robinson explained to the Stewards that the greyhound may have been affected by the heat over the last few days.
