After taking evidence from Handler, George Dailly (representing Trainer - Andrea Dailly) and taking into account the injuries sustained to the greyhound, the Stewards invoked GAR98(1)(d) in lieu of GAR96(2) and have directed the greyhound must perform a Satisfactory Trial (all tracks) before any future nomination will again be accepted.
