Stewards charged Alabama Miss with contravention of AGRR 80.2 for failing to pursue the lure with due commitment entering the back straight. After taking evidence from Trainer, B. Keel, and taking into account the injuries sustained, the Stewards invoked AGRR 82.1(d) in lieu of AGRR 80.2 and will require the greyhound to perform a Satisfactory (all tracks) before any future nomination will again be accepted. Assassinate was also vetted following the Event and Dr. Indrawirawan reported that the greyhound sustained injuries to the right triangle muscle and recommended the greyhound be stood down from competing for 10 days. Stewards charged Assassinate with contravention of AGRR 80.2 for failing to pursue the lure with due commitment on the third turn and again in the home straight. After taking evidence from Trainer, R. Keating, and taking into account the injuries sustained to the greyhound, the Stewards invoked AGRR 82.1(d) in lieu of AGRR 80.2 and have directed that the greyhound must perform a Satisfactory Trial (all tracks) before any fu
