Stewards charged Wisdom Cove with contravention of GAR96(2) for failing to pursue the lure with due commitment on the first turn. After taking evidence from Trainer, Clifford Smith, and taking into account the injuries sustained to the greyhound, the Stewards invoked GAR98(1)(d) in lieu of GAR96(2) and have directed that the greyhound must perform a Satisfactory Trial (all tracks) before any future nomination will again be accepted.</p>
