Tyrant Tyrian and Boulder Dash were slow to begin.</p> <p>Tyrant Tyrian (checked approaching the first turn and lost ground) underwent a post-race veterinary examination and was found to have a gracilis muscle injury. A 21 day stand down period was imposed.</p> <p>Supplementary Report - 15/5/24 - The 10-day stand-down under GAR 101 and \$100 fine were both cancelled due to the identification of a clerical error when recording the weight at the satisfactory trial on 2/5/24 within FastTrack.
