Acting under the provisions of GAR 125, Tiger Stripes was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Nash pleaded guilty to the charge. Tiger Stripes must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Chopper Juice (visibly eased and turned it's head outwards in the home straight), underwent a post-race veterinary examination and was found to have a left hamstrings injury. Acting under the provisions of GAR 125, Chopper Juice was charged with failing to pursue the lure with due commitment (by reason of injury). Ms. Knight pleaded guilty to the charge.
