Acting under the provisions of GAR 124, Hook Shot was charged with failing to pursue the lure with due commitment. Mr. McKenzie pleaded guilty to the charge. Hook Shot was suspended for 28 days at Warragul and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
