Blue Tick Stella raced wide throughout the event. Chocolate Blue (lost ground in the home straight), underwent a post-race veterinary examination and re-vetted following race 6 – no apparent injury was reported. Stewards spoke to representative Mr. Darren Peterson regarding Chocolate Blue's performance from the home turn to the winning post. After hearing submissions from Mr. Peterson, viewing the available race footage and acting on their observations, Stewards deemed the performance of Chocolate Blue unsatisfactory. Chocolate Blue must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted. A post-race sample was taken from Saint Finnie – the winner of the event.</p>

Galaxy Bale (severely checked and lost ground turning off the back straight), underwent a post-race veterinary examination – no apparent injury was reported.</p>
<p><b>Race 3</b> WANNON FUNCTION CENTRE (275+RANK) 2:52 pm 390m Grade 7</p>	<p>Mention was quick to begin. Ronny Allsorts was slow to begin. Tubman's Legacy (collided with Mention several times in the home straight), underwent a post-race veterinary examination – no apparent injury was reported. Stewards spoke to trainer Mr. Colin Brennan regarding the racing manners of Tubman's Legacy in the home straight. After hearing submissions from Mr. Brennan, viewing the available race footage and having their own observations, Stewards took no further action.</p>

Flying Panama underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to representative Mr. Darren Peterson regarding the greyhound pulling up prior to the return gate and failing to enter the catching pen. After hearing evidence from Mr. Peterson, viewing the available race footage and acting on their observations, Stewards issued a warning.</p>

Stewards spoke to representative Mr. Darren Peterson regarding Mick's Delight's overall performance in the event. After hearing submissions from Mr. Peterson, viewing the available race footage and acting on their observations, Stewards deemed the performance of Mick's Delight unsatisfactory. Mick's Delight must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.</p>
