<p>Race 1 CITY VIEW BISTRO 6:45 pm 525m Maiden</p>	<p>A pre-race urine sample was taken from Kansas Chief.</p> <p>Mr. Daniel Gibbons was fined \$50 for failing to ensure the registration card was produced for Toxic Slime, pursuant to GAR 88.</p> <p>Paw Mantra was quick to begin. Scotch Time was slow to begin.</p> <p>Kansas Chief raced wide turning into the back straight.</p> <p>Scott Micah (marred Hey Presto in the home straight) underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to trainer Mrs. Emma Scott regarding Scott Micah's racing manners. Acting under the provisions of GAR 123, Scott Micah was charged with marring. Mrs. Scott pleaded guilty to the charge. Scott Micah was suspended for 28 days (1st offence) at The Meadows and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post-race urine sample was taken from Hey Presto - the winner of the event.</p>

<p>Race 2 AMRON BOY AT STUD 7:08 pm 525m Maiden</p>	<p>Pursuant to GAR 75(6), Club Official Mr. Stephen Brincat did not act in any official capacity that may have in any way affected the outcome of this event.</p> <p>Blazing Frankie and Scud were quick to begin. Iowa Lass and Drop Of Ink were slow to begin.</p>

Cabao Dewberry, Barooga Pete, White Shiraz and Shima Harley were slow to begin.</p> <p>Due to a judging issue, the photo finish image for this event does not fully capture the nose of Destini Rebel - the winner of the event. Prior to calling the All Clear, the Judge and Stewards confirmed the correct winning greyhound acting on their own observations, the race vision, and with the assistance of the partial photo finish image that has been published on FastTrack. Using the back up timing system and the Isolynx data, the Judge was able to manually calculate the margin between Destini Rebel (first place) and Barooga Pete (second place). The remainder of the margins and times for this event were able to be calculated using the partial photo finish image.</p>

<p>Race 7 THE WATCHDOG APP (1-4 WINS) 8:48 pm 600m Restricted Win</p>	<p>Mclvor Olly (tired over the concluding stages) underwent a post-race veterinary examination - no apparent injury was reported.</p> <p>A post-race urine sample was taken from Mclvor Alfy - the winner of the event.</p>
<p>Race 8 TOTAL CONTAINER SOLUTIONS 9:12 pm 525m Grade 5 T3</p>	<p>Crusoe Pearl was quick to begin. Interstate Girl and Tigger Intention were slow to begin.</p> <p>Crusoe Pearl (faltered in the back straight before visibly easing and turning head outwards in the home straight) underwent a post-race veterinary examination and was found to have injuries to the left triceps muscle and right hamstring and a right hock sprain. A 21 day stand down period was imposed. Stewards spoke to kennel representative Mr. Jeffrey Abela regarding Crusoe Pearl's racing manners. Acting under the provisions of GAR 125, Crusoe Pearl was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Abela reserved his plea to the charge. Crusoe Pearl was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Frypan Lomar (repeatedly marred by Tigger Intention over the concluding stages of the event) underwent a post-race veterinary examination - no apparent injury was reported.</p> <p>Stewards spoke to kennel representative Mr. Dylan Sharp regarding the racing manners of Hibiki Blue approaching the turn out of the front straight. After hearing submissions from Mr. Sharp, viewing the available race footage and having their own observations, a warning was issued.</p> <p>Tigger Intention (marred Frypan Lomar turning into the home straight) underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to kennel representative Mr. Tom O'Neill regarding Tigger Intention's racing manners. Acting under the provisions of GAR 123, Tigger Intention was charged with marring. Mr. O'Neill pleaded guilty to the charge. Tigger Intention was suspended for 28 days (1st offence) and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted. Tigger Intention was ordered to wear an anti-aggression muzzle in all future events in accordance with GAR 131.</p>
<p>Race 9 SPORTSBET HT1 9:28 pm 525m Mixed 6/7 Heat</p>	<p>A pre-race urine sample was taken from Reiko Dusty.</p> <p>Paw Dimetra was quick to begin. Reiko Dusty and Mad Kev were slow to begin.</p>
<p>Race 10 SPORTSBET HT2 9:46 pm 525m Mixed 6/7 Heat</p>	<p>Paw Helion was slow to begin.</p> <p>Stewards spoke to trainer Mr. Mark Delbridge regarding the racing manners of Paw Helion in the home straight. After hearing submissions from Mr. Delbridge, viewing the available race footage and having their own observations, a warning was issued.</p> <p>Sweet Begonia tired over the concluding stages of the event.</p> <p>Due to a timing issue, Stewards noted that the incorrect winning time was initially posted to the semaphore board. This was corrected to the actual winning time of 30.370 prior to Stewards calling the All Clear.</p>
