<p><b>Race 1</b> SPORTSBET FINAL 6:17 pm 515m Maiden Final</p>	<p>Paw Gunner, Canya Striker, Paw Fredrick and Paw Petrov were quick to begin.</p> <p>Canya Striker (brushed the inside running rail turning out of the front straight) underwent a post-race veterinary examination and was found to have an abrasion on the left hind leg. No stand down period was imposed.</p> <p>A post-race urine sample was taken from Paw Fredrick – the winner of the event.</p>

Idyllic Luther was slow to begin.</p> <p>Winston Town underwent a post-race veterinary examination at the trainer's request and was found to have a split webbing on the left hind. A 14 day stand down period was imposed.</p> <p>A post-race urine sample was taken from Tokyo Heist – the winner of the event.</p>

Ultimate Jewel was slow to begin.</p> <p>Ultimate Jewel (checked and faltered on the first turn before subsequently pulling up) underwent a post-race veterinary examination and was found to have a right hock fracture. A 90 day stand down period was imposed.</p> <p>Following the running of this event, Stewards inspected the track on the first turn and deemed it suitable for racing.</p>

<p><b>Race 6</b> MONDAY NIGHT RACING AT SANDOWN 8:08 pm 715m Mixed 4/5</p>	<p>A urine sample was taken from Emerley Zoe upon arrival at the course.</p> <p>Liveable and Emerley Zoe were quick to begin. Lilly Intention was slow to begin.</p> <p>Due to an issue with the timing system, the third split for this event did not properly display on the semaphore board. Using the Isolynx data, the judges calculated the third split for this event to be 30.54.</p>

<p><b>Race 7</b> TOONGABBIE LODGE 8:29 pm 515m Grade 5</p>	<p>A pre-race urine sample was taken from Hector Fawley.</p> <p>House of Turbo was quick to begin. Alpha Zulu and Fred Rose were slow to begin.</p> <p>Hector Fawley (severely checked and fell after the winning post) underwent a post-race veterinary examination and was found to have an injury to the left sartorius muscle. A 5 day stand down period was imposed.</p>

<p><b>Race 10</b> VIC NATIONALS SPRINT FINAL 9:25 pm 515m S/E Final</p>	<p>Stormy Day and Funny Old Fellow were quick to begin. Flying Zulu was slow to begin.</p> <p>Stormy Day (faltered turning into the back straight and subsequently tailed off) underwent a post-race veterinary examination and was found to have a right triceps muscle injury and right scapula soreness. A 14 day stand down period was imposed.</p> <p>Orli Bale (turned head outwards turning into the home straight) underwent a post-race veterinary examination – no apparent injury was reported. Stewards spoke to kennel representative Mr. Jordan Bryce regarding Orli Bale's racing manners. Acting under the provisions of GAR 124, Orli Bale was charged with failing to pursue the lure with due commitment. Mr. Jordan Bryce pleaded not guilty to the charge. Orli Bale was found guilty and suspended for 28 days (1st offence) at Sandown Park and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post-race urine sample was taken from Smooth Plane - the winner of the event.</p> <p>Following the running of this event, Stewards inspected the track between the first and second turn and deemed it suitable for racing.</p>
