A 3 day stand down period was imposed.</p> <p>Stewards spoke to Trainer Mr T.Boehmke regarding Craig Keeping overall performance in the event. In accordance with GAR 122, the Stewards requested Mr Boehmke to report as soon as practicable anything that may have affected the running of Craig Keeping in the event, which was not noted by Stewards during or immediately after the event.</p> <p>Canya Enhance (racing manners approaching the winning post) underwent a post-race veterinary examination and was found to have abrasions. A 3 day stand down period was imposed. Stewards spoke to trainer Mr. Mark Roberts regarding the racing manners of Canya Enhance approaching the winning post. After hearing submissions from Mr. Roberts, viewing the available race footage and having their own observations, the Stewards issued a warning to connections.</p>

Another Fifty (lost ground entering the back straight) underwent a post-race veterinary examination and was found to have a right back muscle injury. A 10 day stand down period was imposed.</p>
<p>Race 10 SHIMASHINE AT STUD 6:39 pm 425m Tier 3 - Grade 7</p>	<p>Tornado Jack, Kid George and Aston Blend were slow to begin. Kraken Cool (marred Tornado Jack entering the home straight) underwent a post-race veterinary examination and was found to have a right fore carpus abrasion injury. A 3 day stand down period was imposed. Stewards spoke to Trainer Mr K.Eyles regarding Kraken Cool's racing manners turning into the home straight. Acting under the provisions of GAR 123, Kraken Cool was charged with marring. Mr Eyles pleaded not guilty to the charge. Kraken Cool was found guilty and suspended for 28 days at Bendigo and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
