<p style="text-align: center;">Race 1</p> <p>GREYHOUND ADOPTION PROGRAM 12:13 pm 300m Maiden</p>	<p>Crypto Tiger was slow to begin.</p> <p>Fitzroy Halle (faltered at the 150m mark and tailed off) underwent a post-race veterinary examination and was subsequently re-examined. Fitzroy Halle was found to have a left pectoral muscle injury. A 10 day stand down period was imposed. Pursuant to GAR 122, the Stewards requested Kennel Representative Ms. Paula Boots to report as soon as practicable anything that may have affected the running of Fitzroy Halle in the event, which was not noted by Stewards during or immediately after the event.</p> <p>La Vista Express (raced erratically throughout the event) underwent a post-race veterinary examination and was found to have an injury and laceration to the right stopper. A 10 day stand down period was imposed. Stewards spoke to Ms. Paula Boots regarding the racing manners of La Vista Express throughout the event. After hearing submissions from Ms. Boots, viewing the available race footage and having their own observations, Stewards took no further action. In arriving at this decision, Stewards formed the view that La Vista Express attempted to cross to the outside for the duration of the event. Whilst this action caused significant interference, Stewards were of the view that the greyhound's racing manners did not constitute a breach of the rules.</p> <p>Stewards spoke to Mr. Gerard O'Keefe regarding the racing manners of After The Bell approaching the winning post. After hearing submissions from Mr. O'Keefe, viewing the available race footage and having their own observations, a warning was issued.</p> <p>Stewards spoke to Mr. Frank Andrighetto regarding the racing manners of Redgum Wars approaching the winning post. After hearing submissions from Mr. Andrighetto, viewing the available race footage and having their own observations, a warning was issued.</p> <p>Stewards spoke to Mr. Scott James regarding the racing manners of All Done Up. Barber did not act, in any official capacity, for this event.</p> <p>Aston Merrick - New declared weight of 30.7kg, last raced at 31.8kg.</p> <p>Naughty King was quick to begin. Oriental Estella was slow to begin.</p> <p>Little Truck (visibly eased approaching the winning post) underwent a post-race veterinary examination and was found to have a left quadriceps injury. A 7 day stand down period was imposed. Stewards spoke to Mr. Matt Johnson regarding Little Truck's racing manners approaching the winning post. Acting under the provisions of GAR 125, Little Truck was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Johnson pleaded guilty to the charge. Little Truck was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Aston Merrick baulked approaching the winning post. Stewards spoke to Mr Grant Fullerton regarding the racing manners of Aston Merrick approaching the winning post. After hearing submissions from Mr. Fullerton, viewing the available race footage and having their own observations, Stewards took no further action.</p> <p>A post-race urine sample was taken from Little Truck - winner of the event.</p>
