Race 1 "THE SHED" @ Healesville Greys 11:37 am 300m Maiden	A pre-race sample was taken from Feisty Amy. Waikiki Pearl and King Plum were slow to begin. Waikiki Pearl raced wide throughout. Dream On Franky (visibly eased and pulled up approaching the winning post) underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to kennel representative Mr. Jimmy Holt regarding Dream On Franky's racing manners. Acting under the provisions of GAR 124, Dream On Franky was charged with failing to pursue the lure with due commitment. Mr. Holt pleaded guilty to the charge. Dream On Franky was suspended for 28 days (1st offence) at Healesville and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
Race 2 SPORTSBET FINAL 11:54 am 300m Mixed 6/7 Final	Donatello Zeal was slow to begin. Stewards spoke to Mr. Garry Johnson regarding the racing manners of Queen Kate over the concluding stages. After hearing submissions from Mr. Johnson, viewing the available race footage and having their own observations, a warning was issued.

After hearing submissions from Mr. Fullerton, viewing the available race footage and acting on their observations, Stewards deemed the performances of Aston Hartlett and Aston Houston unsatisfactory; both greyhounds must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nominations will be accepted.

Stewards noted that the semaphore board incorrectly showed 'Race 4' immediately after the running of this event. This was corrected to 'Race 5' prior to the All Clear being given.

Zipping Olaf was slow to begin. A post-race blood sample was taken from Taste Of Hell - the winner of the event.
