Mr. Stemmer subsequently returned to the course with Sleek Machine and completed those requirements. Mr. Stemmer was issued with a warning, pursuant to GAR 94(2). Stewards further spoke to Mr. Stemmer regarding his conduct on the telephone when initially directed to return to the course. Stewards issued Mr. Stemmer with a warning for inappropriate conduct, pursuant to GAR 165(a).</p>
