Acting under the provisions of GAR 124, Maja Manatee was charged with failing to pursue the lure with due commitment. Mr McKay pleaded guilty to the charge. Maja Manatee was suspended for three months (5th offence) all tracks and must perform two Satisfactory Trials in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
