Where's Echo (lost ground from the back straight), underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to Representative - Mr B Grant regarding the performance of Where's Echo during the event. After hearing submissions from Mr Grant, viewing the available race footage and acting on their observations, Stewards deemed the performance of Where's Echo to be unsatisfactory. Where's Echo must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.

A pre-race and post-race urine sample could not be obtained from Forgotten Time. A subsequent blood sample was taken from Forgotten Time - Placed 2nd in the event.
