Stewards spoke to Mr. Gerard O'keeffe regarding Wizard Of Oz performance and racing manners in running. After hearing submissions from Mr O'keeffe, viewing the available race footage and acting on their observations, Stewards deemed the performance of Wizard Of Oz unsatisfactory. Wizard Of Oz must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.
