At the commencement of kennelling, the outside temperature was 27 degrees and the kennel temperature was 18.3 degrees.</p> <p>The closing time of kennelling was altered in accordance with GAR 86 due to the late arrival of several trainers who experienced significant traffic delays en-route to the track. The kennels closed at 6:20pm.</p> <p>Pursuant to the GRV Hot Weather Policy, Stewards dispensed with two requirements prior to Race 1, meaning greyhounds were no longer required to remain on course for the specified time, and that the parading of greyhounds was to occur, as the outside temperature had decreased to a reasonable level.</p> <p>---</p> <p>Honey Bunny was quick to begin. Acting under the provisions of GAR 125, Calm The Storm was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Radstock pleaded guilty to the charge. Calm The Storm must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

Applicant (checked turning into the back straight) underwent a post-race veterinary examination and was found to have injuries to the right wrist and left triceps muscle. A 10 day stand down period was imposed.
