After hearing submissions from Ms. Mallia, viewing the available race footage and acting on their observations, Stewards deemed the performance of Quest For Bolt unsatisfactory. Stewards determined that whilst Quest For Bolt made head or muzzle contact with the rear of the greyhound Big Boss Gible, the action itself did not meet the required criteria for marring. However, Stewards maintain that Quest For Bolt's actions were ungenerous in nature. Quest For Bolt must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Dark Miracle (checked turning off the back straight) underwent a post-race veterinary examination.
