Acting under the provisions of GAR 125, White Iverson was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Armstrong pleaded guilty to the charge. White Iverson must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
