At the commencement of kennelling, the outside temperature was 25 degrees and the kennel temperature was 17.2 degrees. Stewards continually monitored the temperature at the venue, as per the GRV Hot Weather Policy. Outlawed – New declared weight of 33.6 kg, last raced at 32.0 kg.
	Flying Mckeon (galloped on and severely checked at the 50m mark) underwent a post-race veterinary examination and was found to have an abrasion over the left fore accessory carpal bone. A 3 day stand down period was imposed.
