- Little Chatter was found to have a right deltoid muscle injury. A14 day stand down period was imposed.
- Wendy's Joy was found to have no apparent injury.

Cordova was very slow to begin. A post-race veterinary examination revealed no apparent injury. Stewards spoke to Mr. Matthew Clark regarding Cordova's actions in the starting boxes and at box rise. After hearing submissions from Mr. Clark, viewing the available race footage, and having their own observations, the Stewards issued a warning. Stewards will monitor the box manners of Cordova in future events.
