The greyhound was also found to have a spike wound to the left hind. A 21 day stand down period was imposed.</p> <p>Miami Ticket - Slow to begin with muzzle caught in its teeth, successfully dislodged muzzle soon after the start whilst losing ground. Approaching the home turn again was affected by its muzzle and lost ground. Underwent a post-race veterinary examination - no apparent injury reported.</p>

Acting under the provisions of GAR 125, Gossip Girl was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Frost pleaded guilty to the charge. Gossip Girl must perform a satisfactory trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
