Kennel representative Mr. Clint Capuano declined the option to have the greyhound re-examined. Stewards spoke to Mr. Capuano regarding Comeback Charlie's racing manners soon after the start. Acting under the provisions of GAR 124, Comeback Charlie was charged with failing to pursue the lure with due commitment. Mr. Capuano pleaded guilty to the charge. Comeback Charlie was suspended for 28 days (1st offence) at Geelong and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>The announcement of the All Clear was delayed for the Stewards to review the race footage as pigeons were positioned on the track in the home straight and alighted as the greyhounds approached. After viewing the footage and acting on their own observations, the Stewards were comfortably satisfied that no greyhounds were materially affected so as to affect the outcome of the event.
