<p><b>Race 1</b> 13 RACES TODAY (300+RANK) 3:02 pm 450m Maiden</p>	<p>A pre-race urine sample was taken from Bindy Blazer.</p> <p>Whipping Along, Nirranda Gracie and Aston Vanessa were slow to begin.</p> <p>Inga Freddy (checked turning into the home straight and lost ground) underwent a post-race veterinary examination and was found to have a right back muscle injury and abrasions to the right metatarsals. A 7 day stand down period was imposed.</p>

<p><b>Race 2</b> SPORTSBET GREEN TICKS (300+RANK) 3:27 pm 390m Maiden</p>	<p>A pre-race urine sample was unable to be obtained from Nova's Fern, a post-race blood sample was subsequently taken.</p> <p>Aston Sovereign was quick to begin. Tindal Jet and Belair Red were slow to begin.</p> <p>Tindal Jet (faltered in the back straight and subsequently tailed off) underwent a post-race veterinary examination and was found to have a right back muscle injury. A 60 day stand down period was imposed.</p> <p>Peachy Keen (checked turning into the home straight and lost ground) underwent a post-race veterinary examination and was found to have severe pannus to the left eye. Acting under the provisions of GAR 42, Peachy Keen is prohibited from competing in an event until such time as both a veterinary clearance is provided to the satisfaction of Stewards and a Satisfactory Trial is completed, pursuant to GAR 132.</p>

<p><b>Race 3</b> MACEY'S BISTRO (300+RANK) 3:45 pm 390m Grade 7</p>	<p>A pre-race urine sample was taken from Basement.</p> <p>Minh Candy was quick to begin. Squeegee's Ride, Basement and Long Reef were slow to begin.</p>

<p><b>Race 4</b> MATKO HIRE (300+RANK) 4:02 pm 390m Grade 5</p>	<p>A pre-race urine sample was taken from Rich Flex.</p> <p>Bebop Gibley was quick to begin. Inga Leah was slow to begin.</p> <p>Inga Leah (lost ground over the concluding stages) underwent a post-race veterinary examination and was found to have a left back muscle injury and a right front split webbing. A 21 day stand down period was imposed.</p>

<p><b>Race 5</b> BROAD TREE CARE (300+RANK) 4:21 pm 450m Mixed 6/7</p>	<p>Alice Express – Late scratching at 2:38pm on the advice of the On- Track Veterinarian (GAR 92) due to a laceration to the right thigh. A 10 day stand down period was imposed.</p> <p>A pre-race urine sample was taken from Aussie Flame.</p> <p>Moraine Max and Aussie Flame were quick to begin. Timmy Time was slow to begin.</p> <p>Running Sinker underwent a post-race veterinary examination and was found to have injuries to the left back muscle and left pectineus. A 10 day stand down period was imposed. Stewards spoke to representative Ms. Nadine Jack regarding the racing manners of Running Sinker in the back straight. After hearing submissions from Ms. Jack, viewing the available race footage and having their own observations, a warning was issued.</p> <p>Moraine Joker (checked turning off the back straight and subsequently fell) underwent a post-race veterinary examination - no apparent injury was reported.</p> <p>Aussie Flame underwent a post-race veterinary examination and was found to have a left back muscle injury. A 14 day stand down period was imposed. Stewards spoke to representative Mr. Cameron Taylor regarding the greyhound pulling up prior to the return gate and failing to enter the catching pen. After hearing evidence from Mr. Taylor, viewing the available race footage and acting on their observations,</p>

Stewards issued a warning. Furthermore, pursuant to GAR 122, the Stewards requested Mr. Taylor to report as soon as practicable anything that may have affected the running of Aussie Flame in the event, which was not noted by Stewards during or immediately after the event.

Due to Moraine Joker falling and returning the wrong way down the back straight, the lure was pulled up sharply (after going through the catching pen apron) to avoid a collision with the oncoming greyhound.
