Hi Good Thanks is not permitted to compete for 10 days in any other Event. Trainer, Mr M Callanan was fined \$100.</p> <p>Thunderstone was quick to begin. Auntie Amber was slow to begin. Solar Kate raced wide from the first turn.</p> <p>Solar Kate, faltered turn off back straight, underwent a post–race veterinary examination and was found to have right foreleg shin soreness. A 7 day stand down period was imposed.</p>

Aviation raced greenly throughout and wide on the home turn.</p> <p>Black Noveau, lost ground approaching home turn, underwent a post–race veterinary examination and was found to have a wound to the left stopper and strain to the left sartorius muscle. A 5 day stand down period was imposed.</p>

A 5 day stand down period was imposed. Stewards spoke to representative Ms Sandra Elmes regarding Arctic Glamour's racing manners entering the home straight. Acting under the provisions of GAR 123, Arctic Glamour, was charged with marring. Ms Elmes pleaded guilty to the charge. Arctic Glamour, was suspended for 28 days (2nd offence) at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Smiling Bee, checked and lost ground soon after start, underwent a post–race veterinary examination and was re–examined following Race seven. Smiling Bee was found to have a right triangle muscle injury. A 7 day stand down period was imposed.</p>

A 7 day stand down period was imposed.</p> <p>Straight Speed - marred Suntory Lisa in the home straight, underwent a post-race veterinary examination and was found to have a hygroma on the left elbow. No stand down period was imposed.</p> <p>Stewards spoke to trainer Mr C Bermingham regarding Straight Speed's racing manners in the home straight. Acting under the provisions of GAR 123, Straight Speed was charged with marring. Mr C Bermingham pleaded guilty to the charge. Straight Speed was suspended for three months (3rd offence) at all tracks and must perform two Satisfactory Trials in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
