Acting under the provisions of GAR 42, Sundowner is prohibited from competing in an event until such time as both a veterinary clearance is provided to the satisfaction of Stewards and a Satisfactory Trial is completed pursuant to GAR 132. Further, under the provisions of GAR 42(3), Sundowner is suspended from racing for 3 months at all tracks.</p> <p>A post-race urine sample was taken from Thermal Spark – placed third in the event.</p>
