Acting under the provisions of GAR 123, Play The Victim was charged with marring. Mr. Brandon pleaded guilty to the charge. Play The Victim was suspended for 28 days (1st offence) at Sandown Park and must perform a satisfactory trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted. Play The Victim was also ordered to wear an anti-aggression muzzle in all future events, in accordance with GAR 131.</p>

Kennel representative Mrs. Lisa Delbridge declined the option to have the greyhound re-examined. Stewards spoke to Mrs. Delbridge regarding Paw Earnest's racing manners. Acting under the provisions of GAR 124, Paw Earnest was charged with failing to pursue the lure with due commitment. Mrs. Delbridge pleaded guilty to the charge. Paw Earnest was suspended for 28 days (1st offence) at Sandown Park and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Following the running of this event, Stewards inspected the track in the home straight and deemed it suitable for racing.
