<p>Race 5 JVDM GREEN LIGHT ON PODCAST 12:00 pm 350m Grade 5 T3</p>	<p>Thai Butterfly and Hard Rotor were slow to begin. Little Venice tired over the concluding stages of the event, underwent a post-race veterinary examination - no apparent injury was reported. Mr John Brown declined the option to have the greyhound re-vetted. Stewards spoke to Mr Brown regarding the greyhound's performance in the event. After hearing submissions from Mr Brown, viewing the available race footage and acting on their observations, Stewards deemed the performance of Little Venice unsatisfactory. Little Venice must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted. A post-race urine sample was taken from Thai Butterfly - winner of the event.</p>

<p>Race 6 MONTROSE IGALQUOR 12:19 pm 350m Grade 5 T3</p>	<p>Pursuant to GAR 75(7), Steward Miss Demi Barber did not act in any official capacity for this event.</p> <p>Marino and Rob The Butcher were quick to begin.</p> <p>Rob The Butcher turned its head and collided with Marino at the 150m mark and again approaching the winning post. Rob The Butcher underwent a post-race veterinary examination and was found to have a left monkey muscle injury. A 10 day stand down period was imposed. Stewards spoke to Mr Meyer regarding the greyhound's racing manners. Acting under the provisions of GAR 124, Rob The Butcher was charged with failing to pursue the lure with due commitment. Mr Meyer pleaded guilty to the charge. Rob The Butcher was suspended for three months at all tracks and must perform two Satisfactory Trials in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Stewards opened an inquiry into the conduct of Mr Terry Meyer in the wash bay following the event. A charge under GAR 165(a) was issued to Mr Meyer for engaging in conduct that is detrimental and/or prejudicial to the image, welfare and/or interest of greyhound racing. Mr Meyer pleaded guilty to the charge and was fined \$200 with \$100 suspended for a period of 12 months.</p> <p>A post-race urine sample was taken from Cash Now - winner of the event.</p>
