Masseter's weight was amended to 25.7kg.</p> <p>Made Up Stories was quick to begin. Reiko Benny and Paw Savoy were slow to begin.</p> <p>Why Not Ava (lost ground approaching the finishing line) underwent a post-race veterinary examination and was found to have a right sartorius muscle injury. A 10 day stand down period was imposed. Stewards spoke to Mr. Leigh Carter regarding the racing manners of Why Not Ava.
