Trainer Mr Medcraft pleaded not guilty to the charge. Bakali Surprise was found guilty and suspended for 28 days (1st offence) at Meadows only and must perform a satisfactory trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Reiko Terror (turned head outwards turning out of the front straight) underwent a post-race veterinary examination and was re-examined following race 9. Reiko Terror was found to have a right shoulder and right back muscle injury. A 7 day stand down period was imposed. Stewards spoke to representative Mr Joseph Barbara regarding the greyhound's racing manners. Acting under the provisions of GAR 125, Reiko Terror was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Barbara pleaded not guilty to the charge. Reiko Terror was found guilty and must perform a satisfactory trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

After hearing submissions from Mr. Gatt, viewing the available race footage and having their own observations, a warning was issued.
