Mr. Cameron returned to course with Blinked, and completed those requirements. Mr. Cameron was issued with a warning pursuant to GAR 94(2).</p>

Circle Round (raced erratically turning off the back straight) underwent a post-race veterinary examination and was found to have an abraded paw webbing on the right hind. A 3 day stand down period was imposed. Stewards spoke to Mr. Clinton Keith regarding the racing manners of Circle Round turning off the back straight. After hearing submissions from Mr. Keith, viewing the available race footage and having their own observations, a warning was issued. Stewards spoke to handler Ms. Kylie Muscat regarding the difficulty in boxing Circle Round in this event. A warning was issued pursuant to GAR 106(2) and Stewards will continue to monitor the box manners of Circle Round at future starts.</p>
