Race 1

EASIER 11:24 am 300m Tier 3 - Maiden In accordance with the GRV Hot Weather Policy, this meeting was deemed 'Heat Affected'. At the commencement of kennelling, the outside temperature was 19.6 degrees and the kennel temperature was 15.8 degrees. Stewards continually monitored the temperature at the venue, as per the GRV Hot Weather Policy.

A pre-race urine sample was taken from Bruree Luck.

Bruree Luck, Henchmen and Scout's Way were quick to begin. Copperhead Dash, Fitzroy Halle and Spirited Sal were slow to begin.

Scout's Way (checked and lost ground at the 200m mark) underwent a post-race veterinary examination and was found to have a left gracilis injury. A 21 day stand down period was imposed.

A 10 day stand down was imposed. Stewards spoke to Trainer Mr. Geoff Smith regarding Foxy Freckles' racing manners. Acting under the provisions of GAR 125, Foxy Freckles was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Smith pleaded guilty to the charge. Foxy Freckles was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.
