The Starter was also reminded of their responsibilities, pursuant to GAR 105(10) (a).</p> <p>A post-race urine sample was taken from Endeavour - the winner of the event.</p>
<p>Race 3 BARN BAR FUNCTION ROOM 7:29 pm 400m Grade 7</p>	<p>Motivate was slow to begin.</p> <p>Check It Out visibly eased turning into the home straight, underwent a post-race veterinary examination and was found to have a left wrist injury. A 21 day stand down period was imposed. Stewards spoke to Mr. Matthew Clark regarding Check It Out's racing manners. Acting under the provisions of GAR 125, Check It Out was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Clark pleaded guilty to the charge. Check It Out must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Fiesta Azul was severely checked on the first turn and subsequently fell, underwent a post-race veterinary examination and was found to have a right radius/ulna fracture. Fiesta Azul was humanely euthanised.</p>
