#### Race 1

Stewards continually monitored the temperature at the venue, as per the GRV Hot Weather Policy.

During kennelling, Stewards conducted a carpark check on the vehicles of all trainers engaged in today's meeting. Stewards were satisfied that all transport had adhered to the GRV Hot Weather Policy and the GRV Transportation of Greyhounds Policy.

Winifred Mary was quick to begin. Spicy Seduction was slow to begin.

Julie's Girl lost ground in the home straight, underwent a post–race veterinary examination and was found to have left wrist injury. A 14 day stand down period was imposed.

A post-race urine sample was taken from Canya Onslaught - the winner of the event.

Warrior Tommy was severely checked by Brindle Tsunami on the first turn, underwent a post-race veterinary examination and was found to have a right hind spike wound. A 7 day stand down period was imposed. Stewards spoke to Mr. Corey Fulford regarding the racing manners of Warrior Tommy approaching the winning post. After hearing submissions from Mr. Fulford, viewing the available race footage and having their own observations, a warning was issued.
