Contagious Allen raced very wide turning off the back straight. Contagious Allen (racing manners turning off the back straight) underwent a post-race veterinary examination - no apparent injury was found. Stewards spoke to representative Mr. Corey Fulford regarding Contagious Allen's performance and racing manners from turning off the back straight. Mr. Fulford declined the option to have the greyhound re-examined. After hearing submissions from Mr. Fulford, viewing the available race footage and acting on their observations, Stewards deemed the performance of Contagious Allen unsatisfactory. Contagious Allen must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted. Hurricane Polly (faltered turning off the back straight and lost ground) underwent a post-race veterinary examination and was re-examined following Race 10. Hurricane Polly was found to have a spike wound on the right fore toe. A 28 day stand down period was imposed.</p>

Super Speed (contacted the runing rail entering the home straight and lost ground over the concluding stages) underwent a post-race veterinary examination - no apparent injury was reported.</p>

<p>Race 5 SENNACHIE AT STUD 4:22 pm 400m Tier 3 - Grade 6</p>	<p>A pre-race urine sample was taken from Foxy Freckles. Spirit Of Duke was quick to begin. Scott Plenty was slow to begin. Foxy Freckles (faltered turning off the back straight and subsequently tailed off) underwent a post-race veterinary examination and was found to have a fractured right hock. A 90 day stand down period was imposed. Following the running of this event, Stewards inspected the track turning off the back straight and deemed it suitable for racing.</p>

Hay Riley (visibly eased turning off the back straight and again turning into the home straight) underwent a post-race veterinary examination and was found to have no apparent injury. Kennel representative Mr. Corey Fulford declined the option to have the greyhound re-examined. Stewards spoke to Mr. Fulford regarding Hay Riley's racing manners on the first and home turns. Acting under the provisions of GAR 124, Hay Riley was charged with failing to pursue the lure with due commitment. Mr. Fulford pleaded guilty to the charge. Hay Riley was suspended for 28 days (2nd offence) at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Take The Edge (fell after the finishing line) underwent a post-race veterinary examination and was found to have a left shoulder muscler injury and a right hock abrasion. A 5 day stand down period was imposed.
