A 10 day stand down period was imposed. Stewards spoke to trainer Mr. Troy Dorrington regarding Flying Bessie's racing manners. Acting under the provisions of GAR 125, Flying Bessie was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Dorrington pleaded not guilty to the charge. Flying Bessie was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Stewards received a report that the muzzle of Get On Gizmo had become dislodged.</p>

Shaka Big Chief was found guilty and suspended for 28 days at Geelong only (first offence) and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Bali Nights (severely checked and lost ground on the first turn) underwent a post-race veterinary examination was found to have a right-hind abrasion and injuries to the left and right back muscles. A 21 day stand-down period was imposed.</p>
