A 5 day stand down period was imposed.</p> <p>Stewards spoke to trainer, Mr. Peter Dunlevey regarding Sugar Shine's racing manners in the home straight. Acting under the provisions of GAR 125, Sugar Shine was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Dunlevey pleaded guilty to the charge. Sugar Shine must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Moraine Gloria (severely checked in the home straight), underwent a post–race veterinary examination – no apparent injury was reported.</p> <p>Stewards spoke to trainer, Miss. Hillbilly Nova – Unsatisfactory Performance – Field of 4, Distance: 425m, Weight: 36.0 kg, Box 1, Placed 3rd, Time Run 25.15 – Comment: Cleared All Tracks except, Horsham.
