Stewards spoke to Mr. Jordan Formosa regarding the racing manners of Two Foot Toni in the home straight. After hearing submissions from Mr. Formosa, viewing the available race footage and having their own observations, Stewards took no further action.</p> <p>Jiliby Mish (visibly eased in the home straight) underwent a post-race veterinary examination and was re-examined following event 6. Jiliby Mish was found to have injuries to the right sartorius and left shoulder. A 7 day stand down period was imposed. Stewards spoke to Ms. Kate Jackson regarding Jiliby Mish's racing manners in the home straight. Acting under the provisions of GAR 125, Jiliby Mish was charged with failing to pursue the lure with due commitment (by reason of injury).
