Acting under the provisions of GAR 125, Aussie Can was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Bischard pleaded not guilty to the charge. Aussie Can was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
