<p>Race 1 SPORTSBET GREEN TICKS FINAL 6:31 pm 525m Maiden Final</p>	<p>In accordance with the GRV Hot Weather Policy, this meeting was deemed 'Heat Affected'. At the commencement of kennelling, the outside temperature was 33.5 degrees and the kennel temperature was 17.5 degrees. Stewards continually monitored the temperature at the venue, as per the GRV Hot Weather Policy.</p> <p>A pre-race urine sample was taken from Rivia Luffy.</p> <p>Scotch Time and Oregon Indrah were slow to begin.</p> <p>Rivia Luffy (severely checked entering the back straight) underwent a post-race veterinary examination – no apparent injury was reported.</p> <p>Distant (turned head inwards in the front straight) underwent a post-race veterinary examination and was found to have injuries to the left shoulder muscle and right hamstring. A 7 day stand down period was imposed. Stewards spoke to trainer Ms. Leonie Dalton and Mr. Colin Dalton regarding Distant's racing manners in the front straight. Acting under the provisions of GAR 125, Distant was charged with failing to pursue the lure with due commitment (by reason of injury). Connections pleaded not guilty to the charge. Distant was found guilty and must perform a satisfactory trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>

In The Hub (checked and faltered approaching the turn out of the front straight) underwent a post-race veterinary examination and was found to have a right back muscle injury. A 28 day stand down period was imposed.

Kingsley Bale (checked and faltered approaching the turn out of the front straight) underwent a post-race veterinary examination and was found to have a fractured right hock. A 90 day stand down period was imposed.

Nashville Bale (failed to enter the catching pen) underwent a post-race veterinary examination and was found to have a spike wound to the left and right hind leg, no stand down period imposed. Stewards spoke to representative Ms R. Church regarding the greyhound failing to enter the catching pen. Stewards noted that Nashville Bale had failed to enter the catching pen at Sandown on 14 October 2024 and was issued with a warning on that occasion. Acting in accordance with GAR 129, and being mindful of the safety of Nashville Bale, other greyhounds in the race, staff, and participants, Stewards deemed the performance unsatisfactory. Nashville Bale was placed on a satisfactory trial under GAR 129, and pursuant to GAR 132, with the condition that the greyhound must run past the return gate in order to clear the satisfactory trial, before any nominations are accepted.

The track was inspected following the event a deemed satisfactory for racing.
