Stewards spoke to representative Mr. Jimmy Holt regarding Feisty Amy's racing manners. Acting under the provisions of GAR 125, Feisty Amy was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Holt pleaded guilty to the charge.
