Acting under the provisions of GAR 125, Ivory Narwhal was charged with failing to pursue the lure with due commitment (by reason of injury). Ms Knight pleaded not guilty to the charge. Ivory Narwhal was found guilty and must perform a satisfactory trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Cherry Time underwent a post-race veterinary examination at the trainer's request and was found to have injuries to the right monkey muscle and right wrist.
