At a subsequent inquiry, Stewards issued a charge under GAR 86 to Mr Simon Mallia for failing to present the correct greyhound to the Stewards for this event. Mr Mallia pleaded guilty to the charge and was fined \$250.</p> <p>Lucky Indeed was quick to begin.</p> <p>Bull Indeed (severely checked and subsequently fell approaching the 200m mark) underwent a post-race veterinary examination and was found to have a left quadriceps injury. A 10 day stand down period was imposed.</p>

Fireproofed was found guilty and suspended for 28 days (2nd offence) at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
