The kennels closed at 2:49pm.</p> <p>A pre-race urine sample was unable to be obtained from Aston Outlay; a post-race urine sample was subsequently taken.</p> <p>The start was delayed by approximately one minute due to operational activities.</p> <p>Crypto Angel was quick to begin.</p> <p>Rock On Harry (marred Crypto Angel in the home straight) underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to Ms. Lynette Gough regarding the greyhound's racing manners. Acting under the provisions of GAR 123, Rock On Harry was charged with marring. Ms Gough pleaded guilty to the charge. Rock On Harry was suspended for 28 days (1st offence) at Warragul and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Crypto Angel (severely checked from the home turn) underwent a post-race veterinary examination - no apparent injury was reported.</p> <p>A post-race blood sample was taken from Steal The Show - the winner of the event.</p>

Acting under the provisions of GAR 125, Smiley Shoshone was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Crawford pleaded guilty to the charge. Smiley Shoshone must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
