A post-race veterinary examination revealed abrasions to the left metatarsals and right hock. A 3 day stand down period was imposed. Stewards spoke to Mr Jeffrey Britton regarding Robber Baron's racing manners entering the home straight. Acting under the provisions of GAR 123, Robber Baron was charged with marring. Mr. Britton pleaded guilty to the charge. Robber Baron was suspended for 28 days (1st offence) and must perform a Satisfactory Trials in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Buckaroo Barry marred Robber Baron entering the home straight. A post-race veterinary examination revealed a right back muscle injury and an abrasion to the left hind toe. A 14 day stand down period was imposed. Stewards spoke to Ms Susan Richards regarding Buckaroo Barry's racing manners entering the home straight. Acting under the provisions of GAR 123, Buckaroo Barry was charged with marring. Ms. Richards pleaded not guilty to the charge. Buckaroo Barry was found guilty and suspended for 28 days (1st offence) and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>A post-race urine sample was taken from Miles Apart - the winner of the event.</p>

Out To Stagger was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.
