Mepunga Pearl was found guilty and suspended for 28 days at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Mushroom Gravy turned its head outwards on the home turn. Mushroom Gravy underwent a post-race veterinary examination and was found to have a right gracilis muscle injury and left and right carpal sprains. A 10 day stand down period was imposed. Stewards spoke to Mr. Stephen Tabb regarding Mushroom Gravy's racing manners. Acting under the provisions of GAR 125, Mushroom Gravy was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Tabb pleaded guilty to the charge. Mushroom Gravy was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
